There was much discussion about speeding and heavy Lorries:

It was mentioned that if the planning appeal the PC supported regarding the old nurseries were to be successful, that might benefit the situation.

Providing evidence of speeding Lorries and reporting offenders was promoted.

There was a great deal of disappointment expressed with regard to policing speeding and Cllr Cox will progress the matter with the Police and Crime Commissioners office.
